As facilities are not provided at our premises, we will collect items and take them to reputable recycling centres, using domestic facilities as necessary. This includes paper, cardboard, plastic, glass, metal and other recyclables.• We will prevent the release of pollutants that can cause environmental damage by disposing of items such as IT equipment, printer cartridges and batteries through recognised recycling facilities.• We only print documents when absolutely necessary• We send out digital versions of all our proposals, quotes and client documents• We use online billing

Energy	<ul style="list-style-type: none"> Lights and electrical equipment will be switched off when not in use and our heating will be adjusted with energy consumption in mind We have a 'lights off' Friday policy for the office We set an automatic deletion date for emails to reduce mailbox storage requirements We use energy-efficient website hosting We only partner with web hosting providers that use renewable energy sources or have energy-efficient data centers to help our reduce carbon footprint Optimised design and content Our websites use minimal, efficient methods. Designing websites with efficient code, properly compressed images and videos, and minimal use of unnecessary features can help reduce data transfer and energy consumption Caching and content optimisation We use tried and tested methods to maximise website caching and optimisation, which have a significant impact on performance and sustainability PCs are switched off at the end of the working day.
